Dear Name:

This letter is to inform you that on or about December 1, 2008, Advanced Tel, Inc. d/b/a EATEL will no longer be providing domestic or international long distance service within the state of Florida. We are providing this notice well in advance of our target termination date to provide you sufficient time to make the necessary arrangements with another carrier. It is our understanding that domestic and international long distance services are available to you from a number of other carriers. Generally, you will find a list of long distance service providers in your local telephone directory. In order to make your selection, you must contact your long distance service provider of choice and request that your service be switched to that provider.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the FCC releases the public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, referencing the §63.71, Application of Advanced Tel, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

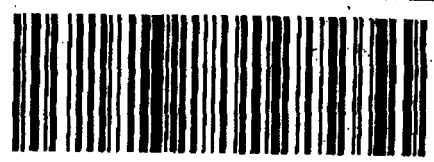

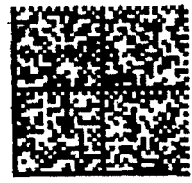
