Further Documentation of Premises Visit Fee

The staff requested more detailed information concerning the reason why a premises visit fee as proposed by the Utility was higher than the charge for a normal disconnect or reconnect fee, since both involve a relatively simple visit to a customer's premises.

Answer:

The Utility contacted the persons who had agreed to provide the premises visit services on behalf of the Utility, and were informed that the quotes for the premises visit were slightly higher than for the disconnect or reconnect charge, because they, by their nature, require additional technician time. The majority of the costs related to all of these services is the trip charge for travel to the customer's location. However, with regard to a disconnect, reconnect, or initial connection, all that is required of the technician visiting the property is to turn a valve and then leave the customer's property. With a premises visit, there is required discussion with the customer, interaction with the customer, and often inspection of an area that relates to the customer's problem. As such, significantly more time is required on the average premises visit than is required for a simple initial connection or disconnection.
