In doing research on Total Solutions Telecom Inc. (TK170), I found in the Florida Department of State, Division of Corporations' records, that Total Solutions and another company called TS Telecommunications, Inc. (TK036) merged into Latin Node, Inc. (TK118) on June 10, 2008. Just as clarification, there were a total of seven corporations merging into Latin Node, but the only two having telecommunication registrations with us are the ones mentioned above.

Also, our records show that Edward Maldonado is the official liaison for each of the three companies mentioned above.

My question to you is should all three registrations be cancelled? If yes, please respond back and advise specifically which companies you are requesting cancellation on. In addition, if the company (or companies) does not pay the Regulatory Assessment Fee, plus any outstanding late payment charges, then we cannot grant the company (or companies) a voluntary cancellation. Instead, the registrations will be cancelled on the PSC's own motion.

Please review this information and let me know as soon as possible how to proceed. Thanks.
