Good morning, Mr. Kyriakides:

Toni McCoy provided me a copy of a letter dated October 8, 2008, that you had attached to an e-mail to her about the cancellation of InterLink Global,Corp.'s IXC registration. It is my understanding you wanted the InterLink IXC registration cancelled effective December 31, 2008, and that you were going to apply for a new IXC registration in the name of Net Talk.com, Inc. on January 1, 2009.
