

RAI Telecom, Inc. is a Delaware corporation with Foreign Authority in Florida. Our entire telecommunications operations are located in New York and no telecommunications services are provided in Florida. Our original plans included retail sales in Florida so we applied for and were issued IXC Registration TJ988. Our retail program never developed and we have decided to respectfully request withdrawal of our Florida IXC authority.

Enclosed is our Interexchange Company Regulatory Assessment Fee (RAF) Return for FY 2007 along with the minimum payment of \$700.

We have been informed by Ms. Paula Isler of the Florida PSC that if this notice of withdrawal is postmarked by January 30, 2008, we will not be liable for any further RAF in Florida.
