## General Data Requests for 080523-TX

Responses to questions 53(b) and 53(c) were non-responsive. As requested in question 53(b), please explain what SOMEC charges are. As requested in 53(c), please breakdown the 911 and other municipal taxes as requested.

#### RESPONSE:

- NewPhone's SOMEC Amortization fee is a charge designed to reimburse NewPhone for the regulated charges imposed by AT&T for ordering via their CLEC "portal". AT&T is allowed to charge CLECs for Mechanized orders at the rate of \$3.50 per order. Over the 7-month life of a typical NewPhone customer, four orders are placed on average. At \$3.50 per order, a cost of \$14.00 is incurred in regulated charges. NewPhone is reimbursed for these charges via our \$2.00 SOMEC Amortization charge billed on a monthly basis.
- The 911 and other municipal taxes of \$1.41 are broken down this way: \$0.70 for Federal USF, \$0.48 for 911 and \$0.23 for Telecom Access Surcharge.
- 55. Are the lines being purchased from AT&T for Lifeline customers in Florida, Lifeline resale lines?
