On February 27, 2007, the Commission issued its Order Granting Water Certificate No. 633-W and Wastewater Certificate No. 542-S in favor of Grove Utilities, Inc. in the above-referenced docket. The docket remained open pending establishment of rates and charges, and each year the Utility is required to file a report indicating the status of its development plan. In lieu of filing such report this letter requests termination of the Certificates of Authority and gives notice of the Utility's withdrawal from any further action in this docket. Due to current economic conditions, and the downturn in the housing market in Florida, the real estate project in Okeechobee County known as The Grove will not be proceeding. Therefore, utility service will not be required. To date, no utility facilities have been constructed and no service is being provided.
