Verizon Long Distance LLC ("VLD") hereby respectfully notifies the Florida Public Service Commission (the "Commission") of the name change of Bell Atlantic Communications, Inc. d/b/a Verizon Long Distance to Verizon Long Distance LLC (the "Name Change"). This name change reflects the company's conversion from a corporation to a limited liability company.

VLD requests that the Commission change the certificates of public convenience and necessity held by Bell Atlantic Communications, Inc. d/b/a Verizon Long Distance to reflect the Name Change to Verizon Long Distance LLC. The Company amended its qualification documents in Florida on December 16, 2008 to accomplish the Name Change. Copies of these documents are enclosed with this letter.


