Dear Mr. Rieger:

On February 8th 2005, as a directive from the Monroe County Board of Commissioners, the original South Stock Island Connection Task Force (CTF) meeting was held (See attached agenda). Members of the CTF who attended this initial meeting and created the CTF tracking tools included; Tom Willi (Monroe County Administrator), Pedro Mercado (County Attorney), Tim McGarry (Monroe County Director of Growth Management), David Koppel (County Engineer), Liz Wood (Monroe County Sr. Wastewater Engineer), Rhonda Norman (Director of Monroe County Code Enforcement), Nancy Dowling (Monroe County Code Enforcement Inspector), Joe Paskalik (Sr. Director / Building Official for Monroe County), Dr. Susana May (Director of Monroe County Health Department), Bobbi Sleighter and Frank Kruppa (Environmental Health Supervisors, Monroe County Health Department), Christopher Johnson (KWRU system operator / inspection company, Keys Environmental) Doug Carter (General Manager KWRU) and Ed Castle (KWRU Engineer).

Attached is CTF SSI, which is the tool that has been used since inception by all CTF members to track all Stock Island connections since February 2005 and will continue to be the tracking device to report the status for the remaining 350 unconnected EDU's. Included in the spreadsheet are; Code Enforcement activities towards those who

refuse to connect to the utility, general status of unconnected properties and an accounting of paid connection charges for those who are not connected.

Also attached is a Memorandum from the Monroe County Senior Sewer Administrator, dated 2/3/09, stating that Monroe County has requested a budget review prior to recommending that the connections be constructed under the existing Capacity Reservation and Infrastructure Contract (contingency funds) for the four customers who do not have service available.

The CTF SSI spreadsheet is not only the most comprehensive analysis and tracking tool for the 350 remaining connections such that it provides everything requested by the PSC order, and we think is the best, most accurate and simplest way to conform to the orders requirements. Therefore that spreadsheet will be the primary document filed to comply with the order requirements for this report each month.

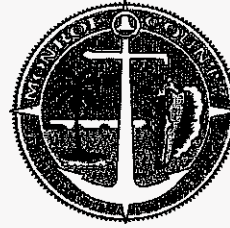
