Attachment #2 - Showing customers that will be sent refund checks (\$249.54) sent to the last known address.

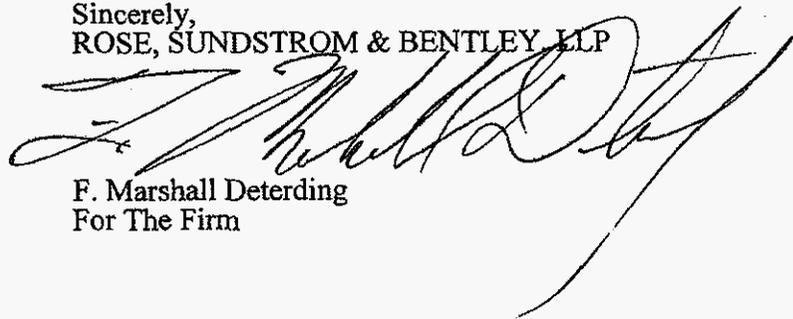
Attachment #3 - Showing customer accounts with credit applied (\$38,534.56).
