Dorothy,

The petition in Docket No. 080733-TP concerns waiving the carrier selection requirements of Rule 25-4.118, Florida Administrative Code, for the transfer of local and long distance customers from four MCI companies to Verizon. However, Verizon neglected to include one of its intrastate interexchange companies in the petition for continued provision of long distance service to the acquired customers. In the attached email, Verizon confirms that Bell Atlantic Communications, Inc. d/b/a Verizon Long Distance, TI483, will serve MCI's long distance customers after the transfer. Therefore, the docket title should be changed to include Bell Atlantic, from:

"Joint petition of MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services; MCI Communications Services, Inc. d/b/a Verizon Business Services; TTI National Inc.; Teleconnect Long Distance Services & Systems Co. d/b/a Telecom*USA; and Verizon Florida LLC for waiver of Rule 25-4.118, F.A.C., due to potential transfer of certain customers from MCI to Verizon as a result of MCI's discontinuation of service to presubscribed residential and small business customers in Verizon's service territory."
