Response to Audit Finding No. 1

We concur with Audit Finding No. 1.

Response to Audit Finding No. 2

We feel the costs disclosed in Audit Finding 2 are appropriate for recovery in our base rates.

The natural gas distribution system and installation agreement negotiated between Florida Public Utilities (FPU) and St. Joe Residential Acquisitions, Inc., the developer of Victoria Park in part requires FPU to provide cooperative advertising dollars. The purpose of cooperative advertising dollars is to assist the developer in promoting natural gas and gas appliances in the development thereby increasing home sales as a result.

Although there is language in the agreement that serves as a guideline when print advertising is used, the cooperative advertising dollars are not limited to print media. The developer has invested in training their internal sales force to become knowledgeable about the benefits of natural gas and the appliances featured in the model homes. One of the primary selling tools of the sales staff is the fact that the development is a natural gas community. The actual growth of the community and the resulting increase in natural gas customers is directly related to the developer's advertising and promotion of natural gas.

Since the 2001 inception of the development known as 'Victoria Park', FPU has added 1,399 new natural gas using customers within the community. The cooperative advertising expenses incurred since inception has been \$216,000 or \$154.39 per customer. In 2007, FPU added 1,375 new natural gas customers to its business, of which 174 were in Victoria Park. In that same year, the company spent \$970,882 advertising energy conservation programs that are designed to defray the customer's cost of natural gas implementation. The cost per customer gained, less those added in Victoria Park (as the expenses for advertising natural gas in that development were paid for out of the non-conservation 913.1 account) averaged \$809.07 per customer.

It is the position of FPU that investments made in cooperative advertising dollars paid to the developer were more cost effective due to the shared interests and the contractual obligations between FPU and the developer. Although the FPU logo embossed on the advertising materials of the developer was relatively small, the effort made by the developer in utilizing the advertising dollars provided by FPU was very effective. The money went into training its sales staff and to promote natural gas in Victoria Park and in fact was more successful than FPU's broad based conservation advertising campaign used to attract customers outside the development. The benefit to existing FPU customers by contracting large scale developments such as Victoria Park to incorporate natural gas into the community is the spreading of imbedded overheads of the company across a greater number of customers.

The \$56,238 forecast for 2009 expenses should be included in the company's base rate request as it is abundantly evident that the advertising investment was valuable, cost effective and beneficial to all customers.

Response to Audit Finding No. 3

We concur with Audit Finding No. 3.

We concur with Audit Finding No. 4.

Response to Audit Finding No. 5

We agree with the findings based on the known facts at the time of this audit. However, it is possible that the board could award additional compensation to the executives for 2009 which could eliminate the need for this adjustment. The projections are reasonable and the compensation paid to executives is appropriate and reasonable.

Response to Audit Finding No. 6

The Company annualized four months of actual expense incurred in January through April 2008 to project the yearly costs for the 2008 utility expense. We then increased the 2008 projections by a trend factor of 7% to project the 2009 expenses. However, the actual annual increase for natural gas office utility expense from 2007 to 2008 was 43% (see Exhibit 6.1). Our projections were actually understated based on actual results for 2008 and new expectations. Therefore we do not feel it would be appropriate to reduce the amount of requested recovery from the current projections.

Response to Audit Finding No. 7

The Company agrees with this finding to increase projected expenses by \$34,215. There was a computation error in the MFR, and this adjustment corrects for that mistake.

We do not agree that the average expense for the four years should be disallowed since this expense is to a large degree noncontrollable on the Company's part, and this is the average amount expected over the four year period that the final rates will be in effect. The revenues collected over this four year period for this expenditure will match the amount of expenses for this period. Medical insurance is a necessary benefit to our employees. The costs have been outpacing inflation over recent years and are expected to continue to do so over the next four years. Our projections were based on our insurance brokers estimate. The Company has taken steps to minimize the impact of the increase to medical costs; however, even with those changes to our benefits costs have continued to outpace inflation and are expected to continue as we have projected.

Response to Audit Findings No. 8

We agree with the concept of the methodology used to determine the allocation of the property taxes, but have a slight difference in the amount of the adjustment required. Our allocation percentage for

the nonregulated portion at the divisional level is 1.07% versus the audit computation of 1.90%. With this correction the adjustment to 2009 should be \$66,363 instead of \$77,852.

We took the actual 2008 plant net of the reserve allocated to the nonregulated operations excluding vehicles. This is a good basis to determine the property and values used to assess the property taxes. Vehicles are not part of the plant that is used to assess our property taxes, and accordingly should not be included for purposes of allocating the appropriate amount of property taxes to our nonregulated operations. See Exhibits 8.1 and 8.2 to review the allocation computation and the revised property tax adjustment.

Response to Audit Finding No. 9

We concur with Audit Finding No. 9.

Response to Audit Finding No. 10

We concur with Audit Finding No. 10. This expenditure should be considered for future recovery as part of our alternative request for recovery on the new operations center in our South Florida operations. In our testimony we suggested alternative recovery for the building and its related direct expenditures.

Response to Audit Finding No. 11

We do not agree with the Staff recommendation for reallocating costs. The Staff's allocation methodology is not consistent for the space in its entirety. The showroom space is allocated 100% to M&J based on the fact that it houses our appliances. The office spaces are based on the payroll charges for the individuals occupying the space. These payroll charges already include M&J relative to the showroom. If the space is to be allocated using payroll, it should be consistently applied to all the space. Any inconsistency would not be a fair representation.

However, we do not feel payroll is the appropriate allocation basis. Our allocation of these expenses based on customers is consistent with prior years and is a fair method to allocate the expenses related to usage of the building. Our prior rate proceedings included these costs, allocated on customer basis and it is how our rates have been set historically. Customer basis is an accurate, easy and consistent approach for allocation.

Exhibit 11.1 contains a list of charges expensed using distribution codes COMCF, OFCCF, SBTCF and WSGCF. The total amount expensed through these distribution codes is \$59,694. Our customer allocation basis results in 87% of this amount (or \$51,934) impacting our natural gas segment. The staff's recommendation of 71.5% results in \$42,681 impacting our natural gas segment. The difference would be a decrease to our natural gas expenses of \$9,253. However, we believe no adjustment is necessary.
