On this Order for South Florida Hospital and Healthcare Association (SFHHA), I don't see that they have filed a request for qualified representative status with the Clerk's Office.

I see that DN 02266-09, in 080677-EI from SFHHA, is asking for a request for qualified representative status. This filing from SFHHA should have been filed it in 090008-OT. They've been in some past years dockets, probably before we started this docket. However, they should be made aware that they must file it in 090008-OT, and every year if they want the status to continue if the docket is still open, and being a representative.

I'm sure you probably know on this docket we require them to file a request every year, if they want to continue. This is part of an Ordering paragraph from the rollover dkt that request filing ---that beginning January 5, 2009, all applications requesting that a person be designated as a qualified representative for calendar year 2009, as contemplated in Rule 28-106.06, Florida Administrative Code, shall be filed and determined in Docket No. 090008-OT.

With a email response from you Timisha, giving the Clerk's Office's permission to move DN 02266-09, in 080677-EI from SFHHA, which is asking for a request for qualified representative status, and that it needs to be moved over to 090008-OT from 080677-EI. We can document the email to move the filing over. Also, please inform SFHHA that the filing for qualified representative status needs to be filed annually if they are to continue their status into the next year. Of course, SFHHA will receive the Order when the rollover Order is issued to parties at the beginning of each year.

As soon as you send us the email response for permission to move the document we can then be able to issue this Order you sent down earlier.
