



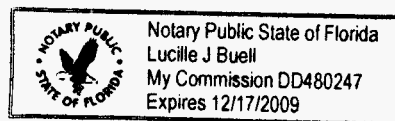

On January 6, 2009, the Florida Public Service Commission approved interim water rates for Placid Lakes Utilities, Inc. The interim rates will be collected subject to refund, pending the Florida Public Service Commission's final decision regarding final rates. If a refund is ordered, it will include interest based upon the Commission determined factors.
