Enclosed for filing, please find one (1) original and three (3) copies of a name change replacement tariff filed on behalf of Verizon Enterprise Solutions LLC. This name change does not affect the rates, terms or conditions of services currently provided to the Company's customers. The Company respectfully requests an effective date of April 28, 2009.

On February 23, 2009 Verizon requested that the Commission change the certificate of public convenience and necessity held by NYNEX Long Distance Company d/b/a Verizon Enterprise Solutions to reflect the Name Change to Verizon Enterprise Solutions LLC, and also requested permission to replace Florida Tariff No. 1 with Florida Tariff No. 2 as a replacement tariff with all original pages. This was approved by the Division of Regulatory Compliance and the Office of the General Counsel and notification was sent to you in a memorandum dated March 26, 2009.


