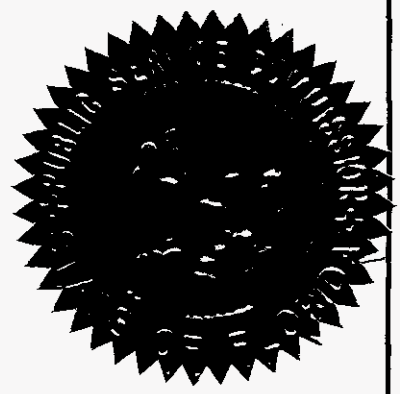

2 CHAIRMAN CARTER: And with that, Commissioners,
3 we are now on Item 11.

4 Staff, you're recognized.

5 MS. KUMMER: This is Connie Kummer with
6 Commission Staff.

7 Commissioners, Item 11 is Tampa Electric's
8 proposal to eliminate the customer charge for its general
9 service load management Riders, GSLM-2 and GSLM-3. At
10 the time of the rate case there were no customers taking
11 service on these riders, and TECO proposed no changes to
12 them so they were not addressed in the rate case.

13 When designing the new Commission-approved IS
14 rate schedule, TECO determined that the customer charges
15 for the underlying rates, IS and GSD, were cost
16 compensatory, and there was no longer a need for a
17 separate customer charge on the riders.

18 CHAIRMAN CARTER: Thank you.

19 Commissioners, any questions for Staff?

20 Commissioner Argenziano, you're recognized.

21 COMMISSIONER ARGENZIANO: Yes, Mr. Chairman.

22 The reason I asked, really, to pull this off of
23 Move Staff was because I wanted to make sure that I was
24 consistent with my vote as I was with the TECO case, so I
25 would be voting no out of consistency.


