GENERAL SUBJECT MATTER TO BE CONSIDERED: DOCKET NO. 080244-EI - Petition for approval of underground conversion tariff revisions, by Florida Power & Light Company.

DOCKET NO. 070231 - Petition for approval of 2007 revisions to underground residential and commercial distribution tariff, by Florida Power & Light Company.
