Hi John,

I am contacting you regarding Brydels Communications, LLC in Florida. The Commission mailed out and received back an IXC Update Form with *AMIGOS Tu Compania de Telefono* crossed out, and the words written "*dba has been cancelled with the Sec of State*". I took this to mean we should delete that name from the IXC registration and I opened an administrative Docket to process the IXC name change when I noticed the company also has a CLEC certification. The Commission didn't receive back an Update Form on the CLEC certificate so I wasn't sure if both the IXC and CLEC required the same name change. I would say yes, but I have to verify that with the Company directly since I don't have anything in writing making that specific request.

The Commission also needs an updated contact phone number and fax number. I emailed [john@brydels.com](mailto:john@brydels.com) with no response, so perhaps an email address update is needed as well.
