AFFIDAVIT OF OSVALDO J. LOM


BEFORE ME, the undersigned authority, personally appeared Osvaldo J. Lom who, being first duly sworn, deposes and says:



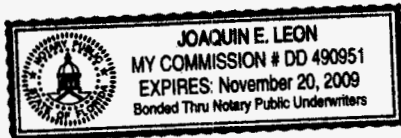

AFFIDAVIT OF GERARD J. YUPP


BEFORE ME, the undersigned authority, personally appeared Gerard J. Yupp who, being first duly sworn, deposes and says:
