**NOTICE OF APPLICATION FOR AMENDMENT TO

Notice is hereby given on the 19 day of August, 2008, pursuant to Section 367.101, Florida Statutes that East Marion Sanitary System Inc., requests permission from the Florida Public Service Commission to amend its Tariff to add an irrigation meter installation charge and amend its current meter installation charge, miscellaneous service charges and amend its connection / transfer sheet. The application has been assigned Docket No. **080562WU**. A copy of the Petition and Stipulation filed with the Commission is available through the Commission and can also be reviewed at the following locations:

The purpose of the proposed amendment to the Utility's Tariff, is to pay for the cost associated with installing irrigation meters for those customers requesting irrigation service. The amendment will only affect customers requesting irrigation meters after the date of application, not customers that already have irrigation meters. It will become effective upon approval by the Commission.

A comparison of the current and proposed charges for irrigation meter installation charges appear on the next page.


