 Turn left onto NW 183rd St./ Miami Gardens Drive/ FL-860 W.



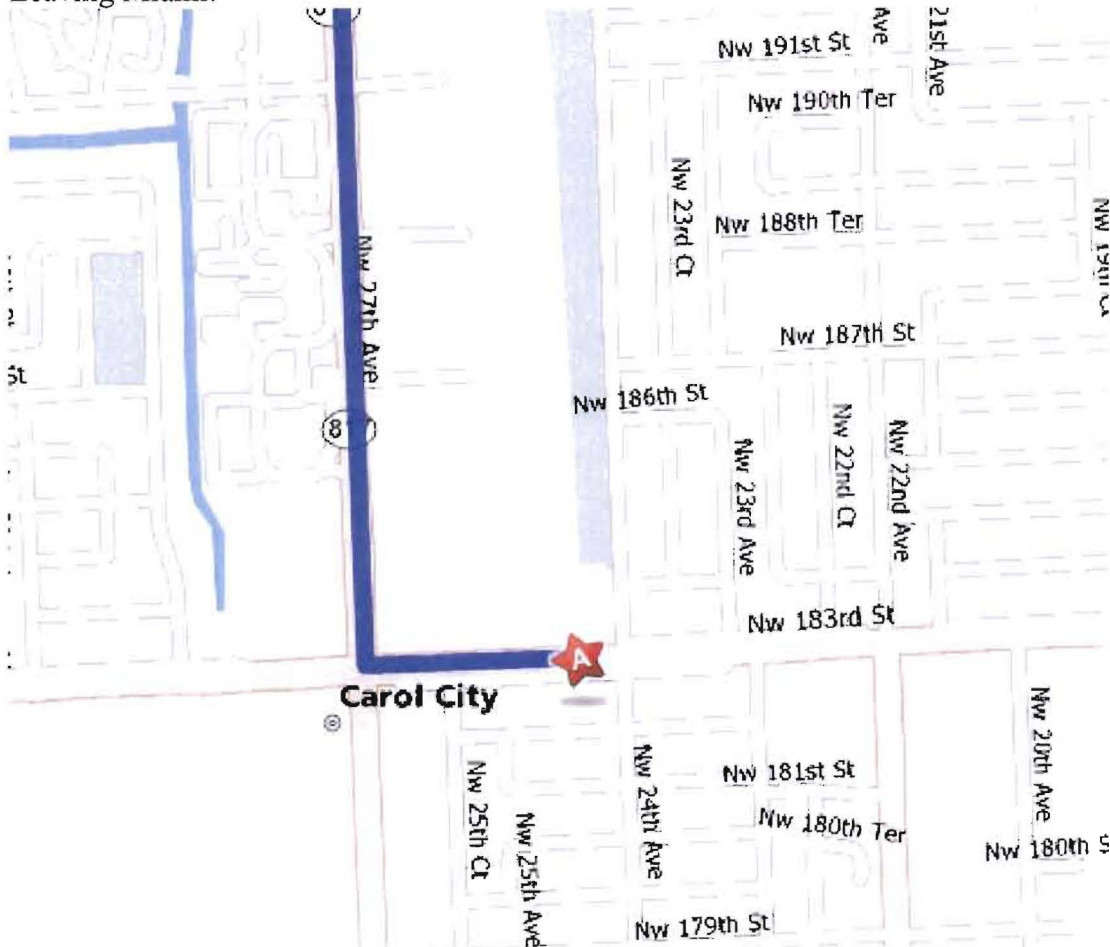
