

2 **COMMISSIONER EDGAR:** Okay. Commissioners, we
3 are on Item 16, a panel of Commissioners Edgar, McMurrian,
4 and Argenziano. And I will ask our staff to introduce the
5 item for us, please.

6 **MS. HARTMAN:** Jean Hartman on behalf of
7 Commission staff.

8 Commissioners, Item 16 is staff's post-hearing
9 recommendation on FPL's petition for approval of its
10 renewable energy tariff and standard offer contract for
11 renewable energy.

12 If the Commission approves staff's
13 recommendation, it is our understanding that FPL would be
14 willing to make the recommended changes to its 2009
15 standard offer contract, which was filed April 1st, 2009.
16 Staff is available to answer your questions.

17 **COMMISSIONER EDGAR:** Thank you.

18 Commissioners, any questions for our staff on
19 Item 16 and the issues therein. No? No questions. Let
20 me just check my notes.

21 Commissioner McMurrian.

22 **COMMISSIONER McMURRIAN:** Are you ready for a
23 motion, Madam Chairman?

24 **COMMISSIONER EDGAR:** I am if you are.

25 **COMMISSIONER McMURRIAN:** Okay. I am. I will do

1 it maybe this way.

2 **MS. HARTMAN:** Commissioners, as to Issue 16, we
3 would --

4 **COMMISSIONER McMURRIAN:** Item 16?

5 **COMMISSIONER EDGAR:** Yes.

6 **COMMISSIONER McMURRIAN:** Do you want me to go
7 ahead?

8 **MS. HARTMAN:** Yes, please.

9 **COMMISSIONER McMURRIAN:** I'll make a motion on
10 Issues 1 through 10 to move the staff recommendation.

11 **COMMISSIONER EDGAR:** We have a motion and a
12 second on Issues 1 through 10. All in favor say aye.

13 (Simultaneous aye.)

14 **COMMISSIONER EDGAR:** Opposed? Show it adopted.
15 That brings us to Issues 11 and 12.

16 **COMMISSIONER McMURRIAN:** And I think consistent
17 with what Ms. Hartman was saying earlier, we would need to
18 modify Issue 11. And I think it would be correct to
19 modify the staff recommendation to stop with -- well, I'll
20 just read it. No, the tariff should be denied as filed.

21 **MS. HARTMAN:** Yes.

22 **COMMISSIONER McMURRIAN:** And then, perhaps, add
23 some language about requiring FPL to refile the 2009
24 version consistent with what you said in your opening.
25 That they would be willing to make the changes to the 2009

1 version, seeing that making changes to the 2008 version,
2 which was the subject of the docket, is perhaps moot at
3 this point, since earlier today we proposed to go forward
4 with the 2009 version.

5 **MS. HARTMAN:** I would agree with that. And I
6 think it would be -- the language you suggested would be
7 appropriate, that the Commission directs FPL to file maybe
8 within 30 days of the Commission's vote today the revised
9 2009 renewable energy tariff and standard offer contract
10 in accord with the Commission's decision herein.

11 **COMMISSIONER McMURRIAN:** So you recommend 30
12 days?

13 **MS. HARTMAN:** Yes.

14 **COMMISSIONER McMURRIAN:** I can move that,
15 Commissioner Edgar.

16 And with Issue 12, should this docket be closed,
17 I believe that would be modified, as well.

18 **MS. HARTMAN:** Yes. We would recommend that if
19 you adopt the revised Issue 11, that Issue 12 just be to
20 close the docket.

21 **COMMISSIONER McMURRIAN:** Okay. So moved.

22 **COMMISSIONER EDGAR:** Commissioner Argenziano,
23 any questions or comments? Can you second?

24 **COMMISSIONER ARGENZIANO:** Sorry, yes.

25 **COMMISSIONER EDGAR:** Okay, thank you. We have a

1 motion and a second on Issues 11 and 12. All in favor say
2 aye.

3 (Simultaneous aye.)

4 **COMMISSIONER EDGAR:** Opposed? Show it adopted.

5 Commissioners, thank you for your patience. And
6 that concludes our business for today. We are adjourned.
