STAFF'S FIRST DATA REQUEST

Re: DOCKET NO. 080517-WS, Application for approval of transfer of Horizon Homes of Central Florida, Inc. and Five Land Group LLC's water and wastewater systems to Aqua Utilities Florida, Inc., and for amendment of Certificate Nos. 441-S and 507-W, in Sumter County.

Dear Mr. Twomey:

Thank you for participating in our April 10, 2009, discussion of the Commission's acquisition adjustment rule with regard to the Jumper Creek water and wastewater systems. Commission staff requests additional information to complete our understanding of the impact of the acquisition of the Jumper Creek systems by Aqua Utilities Florida, Inc (AUF). Please provide responses to the following data requests, using the National Association of Regulatory Utility Commissioners Uniform System of Accounts:

1. AUF's projected operating and maintenance costs for the Jumper Creek water and wastewater systems, including all allocated costs for 2009.
2. Rate base schedules for the Jumper Creek water and wastewater systems which reflect the existing and projected cost of all assets, depreciation, contributions in aid of construction, and amortization, excluding any acquisition adjustment as of December 31, 2009.


