This letter is submitted to object to the subject application for the following reason:

- 1) Recently Wedgefield Utilities managed to get approval from the PSC to raise the water rates by 54% in the Wedgefield subdivision. This was not only an incredibly high increase, but it came during the worst economic crisis since the great depression. As individual homeowners, we did not have any power to stop them and it is still mystery how the PSC working in our behalf could have approved it. I object to the application for transfer under the grounds that this is likely just another attempt by the current owners of Wedgefield Utilities to take further advantage of the homeowners and in addition free themselves from some liabilities that we are not even aware of.
