Dear Mr. Amison:

Thank you for your letter in which you voiced your objection to the proposed centralized wastewater system on St. George Island in the above-referenced docket. Please be advised that the Commission's consideration of this matter is limited to the appropriateness of the issuance of an original certificate to serve the commercial district of St. George Island only. That being said, you have several options with regard to your level of participation in this matter.

Before acting on your letter, the Commission must know your intent regarding your objection to the above-referenced certificate issuance in this docket. If you choose to pursue this protest, an administrative hearing will be scheduled. You will have certain rights and responsibilities to put on your case, including filing written testimony, participating in motion practice and formal discovery, filing a prehearing statement, attending a prehearing to be held in Tallahassee, Florida, putting on witnesses and cross-examining utility and other witnesses at the hearing, and filing a post-hearing brief. All of these activities will have due dates that will be required to be met by all parties to this proceeding. Although utility customers may represent themselves at formal hearings before the Florida Public Service Commission, it may be preferable to hire counsel or a qualified representative to represent you.

If you do not wish to pursue a formal hearing, your letter will be placed in the correspondence side of the docket file in this case, where your concerns will remain available for review and informational purposes. Additionally, upon your request, we can send you a copy of staff's recommendation, and you may address the Commissioners at the Agenda Conference.

If you wish to initiate a hearing in the above-referenced docket, please submit a petition initiating formal proceedings in accordance with the requirements of Rule 28-106.201, Florida Administrative Code (F.A.C.), by **Friday, June 12, 2009**. Your petition should be made in writing and should be addressed to the Florida Public Service Commission, Director, Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850. Friday, June 12, 2009, we will assume that you do not wish to pursue a formal hearing, and your letter will be placed in the correspondence side of the docket file in the above-referenced matter.

Your letter also requested to address the Commissioners at any Agenda Conference in this docket. Please be advised that interested persons will not be allowed to speak at the post-hearing Agenda Conference addressing the issuance of an original certificate to Waste Management Services, Inc. (WMSI), as they will already have been provided the opportunity to do so during the prior hearing. However, a motion for rule variance is handled by the Commission as a Proposed Agency Action. Accordingly, interested persons are permitted to speak at the Agenda Conference addressing WMSI's request for a rule variance, and their comments will be considered by the Commission prior to its vote. If you decide to address the Commission on the rule waiver once it has been scheduled, please let me know as soon as possible so I can accommodate your presentation efficiently.
