Dear Ms. Cole:

Pursuant to the requirements of Section D(1) of AT&T Florida's Extended and Modified Service Guarantee Program (SGP) approved by the Florida Public Service Commission, (See Order No. PSC-05-0440-PAA-TL in Docket No. 050095-TL, dated April 25, 2005), AT&T Florida declared a service emergency on May 22, 2009 in Brevard, Volusia, Flagler, St Johns, Duval, Clay, and Nassau counties due to excessive rain.

Effective Tuesday, June 2, 2009, the declared service emergency that was placed into effect in **Brevard, St Johns, Duval, Clay and Nassau Counties** due to the excessive rain will be **eliminated** (see attached NPA/NXX's to be eliminated). The service emergency declared in the remaining counties, Volusia and Flagler will remain in service emergency until further notice.

It will take some additional time for AT&T Florida to recover and regain normal installation and repair activities in these counties. AT&T Florida will continue to provide the Commission updates on our recovery efforts and advise when the service emergency period in the remaining counties has concluded.
