**MOTION FOR EXTENSION**

Virgin Mobile USA, L.P. ("Virgin Mobile" or the "Company"), by undersigned counsel, hereby respectfully requests that the Florida Public Service Commission ("Commission") grant it a brief extension of time to respond to staff's request for additional information regarding the Company's Petition for Limited Designation as an Eligible Telecommunications Carrier ("Petition"), which it filed with the Commission in the above-referenced docket on April 28, 2009.

On May 19, 2009, Commission staff issued an extensive request for additional information regarding Virgin Mobile's Petition. Virgin Mobile is currently working to provide the requested information, but the Company has not been able to complete this process by the June 5, 2009 deadline. Virgin Mobile, therefore, respectfully requests a twenty-one day extension of time to file the information requested by staff. Virgin Mobile will file its responses to the staff's request by June 26, 2009.
