Dear Mr. Averett:

Thank you for taking time to speak with me on June 23, 2009. I have a few follow up questions for you regarding your West Lakeland Wastewater Utility, Inc. (Utility).

### Utility's Books

According to your Notice of Intent to Abandon by West Lakeland Wastewater Utility, Inc., dated March 26, 2009, you stated that the Utility's books are located at 2907 Brooks St., Lakeland FL 33803. I believe you have made these books available to Mr. Mike Smallridge, but if you haven't, would you make these available to Mr. Smallridge prior to June 30, 2009, or sooner? As Receiver, he will need these books, along with other utility records, and a list of current customers, including addresses and outstanding balances.

### Utility's Creditors

Would you or Ms. Butner please provide the Commission an itemized list of all the Utility's creditors, and approximate amounts owed? I recall that you mentioned that the Utility owed some of its suppliers and other various creditors significant amounts of money. Since the Utility is behind on paying the Commission its Regulatory Assessment Fees (RAFs), and has not filed its Annual Reports, please list the Commission as a creditor.

### RAFs & Annual Reports

In addition, with that letter, please inform the Commission whether the Utility intends to pay its back RAFs, penalties, interest, and fines owed, and if not, an explanation why the Utility is unable to pay these. Similarly, will the Utility file its 2007 and 2008 Annual Reports, and if not, would you provide an explanation.


