RESOLUTION NO. 09-124

A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, OBJECTING TO FLORIDA POWER AND LIGHT'S PROPOSED RATE INCREASE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Power and Light ("FPL") is the sole provider of electricity within the City of Sunrise ("City"), and the City and its residents have no alternative but to purchase services from FPL; and

WHEREAS, the City purchases electricity from FPL to power City Hall and numerous municipal buildings in order to provide services to citizens; and

WHEREAS, the residents of the City must purchase services from FPL; and

WHEREAS, the City and its residents are facing a period of limited resources; many homes in the City are being foreclosed; and residents in the City are facing job layoffs and furloughs; and

WHEREAS, the City and its residents are being forced to live within their means and budget accordingly; and

WHEREAS, FPL has proposed a 30% base rate-hike increase in order to ensure a 12.5% return on equity to attract investors; and

WHEREAS, FPL has received recent rate increase approvals, has made a profit in 2008, and is forecasting increased earnings for 2009 and 2010; and

WHEREAS, these rate increases will adversely affect the residents of the City and further strain limited resources.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified as true and correct and incorporated herein by this reference.

Section 2. The City of Sunrise hereby vehemently objects to the Public Service Commission approving FPL's rate increase.

Section 3. Deputy Mayor Rosen is authorized on behalf of the City of Sunrise to present this Resolution opposing the rate increase at the Public Service Commission's public hearing on Thursday, June 25, 2009.

Section 4. The City Clerk is hereby directed to distribute a copy of this resolution via mail to the PSC Clerk, Attention: Docket 080677-E1, 2540 Shumard Oak Blvd., Tallahassee, FL 32399-0850, and via e-mail to the commission at contact@psc.state.fl.us.


Section 5. Effective Date. This Resolution shall be effective immediately upon its passage.
