**SEVENTH NOTICE OF INTENT TO REQUEST

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Seventh Notice of Intent to Request Confidential Classification of the information produced in response to Citizens' Fifth Request for Production of Documents (Nos. 75-80), specifically numbers 75, 76, 78, 79 and 80. The responses to these requests contain confidential and proprietary contractual information, as well as other confidential competitive business information, the release of which would harm PEF's competitive business interests. Furthermore, the release of this information would violate PEF's contractual confidentiality agreements.

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of filing this request.


