**FIRST NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of the documents produced in response to Staff's Tenth Set of Interrogatories (Nos. 123-126). The information being provided in response to these interrogatories contains extremely sensitive, confidential information, the release of which would harm the Company's competitive business interests. More specifically, releasing this information would impair the Company's competitive interests in retaining its skilled personnel and in protecting its investment of time, money and resources for the training of such personnel. For these reasons, PEF is requesting that the Commission afford these documents confidential classification.

PEF is providing as Exhibit A the Confidential information in question.

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification or its Motion for Temporary Protective Order for such confidential information contained therein within twenty-one (21) days of filing this request.


