Good afternoon:

Attached is the 2008 Regulatory Assessment Fee return form for Verizon Avenue. If the company owes the minimum, the total due is \$1,280, which is comprised of the \$600 minimum fee, \$150 penalty, \$30 interest, and the \$500 fine. I've also attached the order imposing the fine.

Another issue is the company's name. The name on its IXC (TJ011) and CLEC (TX134) certificates is: Verizon Avenue Corp. d/b/a Verizon Avenue. I've discussed this with my supervisor and we believe the name on the certificates should probably be changed. One, because the d/b/a is unnecessary because if the corporation is Verizon Avenue Corp., it can just use Verizon Avenue without the need for a fictitious name. The second reason is because the fictitious name expired on December 31, 2006, with the Florida Department of State, Division of Corporations (www.sunbiz.org). The company could reinstate the fictitious name, if that is the route it wanted to take. However, this does need taking care of

because the name on a certificate must match the (active) name(s) with the Division of Corporations. Just let me know by the end of the month how the company wishes to proceed with the name issue. If you need more time to make a decision, that's OK too, just let me know.

As we discussed, our records currently reflect the liaison is Ms. Winters, Coordinator, Network Operations, at 12901 Worldgate Drive, Herndon, VA 20170-6012.
