1. Undersigned counsel has just returned from lengthy travel during which time she did not have access to information relative or necessary to preparation of the prehearing statement.
2. AIF's participation as an Intervenor in the instant matter focuses on support of FPL's rate request as a general matter of public policy it believes will sustain and enhance the state's economic prosperity.
