**Re: Delinquent Regulatory Assessment Fees for C.S.M. Enterprises, Inc.**

Dear Mr. Ste-Marie:

According to our records, C.S.M. Enterprises, Inc. (CSM), has not paid regulatory assessment fees (RAFs), as required by Rule 25-30.120, Florida Administrative Code (F.A.C.), for the year 2007. Pursuant to Rule 25-30.120(2), F.A.C., regulatory assessment fees must be paid by March 31 of each year. Administrative penalties, plus interest, may be imposed as provided for under Rule 25-30.120(7), F.A.C.

Staff's calculation of the appropriate RAFs, plus the appropriate penalty and interest through August 30, 2009, is set out below.

Pursuant to Rule 25-30.120(7)(a)2., F.A.C., CSM continues to be responsible for paying interest of one percent every thirty days on the unpaid balance of the regulatory assessment fees. The amounts shown above have been calculated as of August 30, 2009.

The interest amount changes after August 30, 2009, and increases over time. Any delay in payment past August 30, 2009, will subject CSM to additional interest. In addition, if payment in the above listed amounts is not received by the stated due dates, the Commission may initiate show cause proceedings. If show cause proceedings are initiated, and the utility is found to be in violation of Commission rules, pursuant to Section 367.161, Florida Statutes, the Commission is authorized to impose fines of up to \$5,000 for each day the violation continues.

Your payments of the amounts set forth above should be received by the Commission by August 30, 2009, and should be mailed with a copy of this letter to the Fiscal Services Section, Division of Administration, Florida Public Service Commission, 2540 Oak Boulevard, Tallahassee, Florida 32399-0850, Attention: Valorie Moore.


