**SEVENTEENTH NOTICE OF INTENT TO REQUEST

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of documents produced in response to the Florida Public Service Commission's Staff's ("Staff") Ninth Set of Interrogatories (Nos. 66-76), specifically numbers 67-76. These documents contain confidential competitive business information and documents related to the Levy Nuclear Project ("LNP"). PEF considers this information proprietary and confidential, does not share it with the public, and has at all times maintained its confidentiality. For these reasons, PEF is requesting that the Commission afford these documents confidential classification.
