Ms. Fleming has asked us to confirm to her that:

1. Both PEF and the Intervenors who protested the PAA pension accounting order agree to consolidation of the pension accounting docket (No. 090145-EI) with the rate case docket (No. 090079-EI) so that the protest can be resolved by year end.

2. The three issues we agreed to last week with regard to the creation of a regulatory asset and the deferral of pension expenses (numbers 119, 120 and 121 in staff's composite issue list) are intended as restatements of the three issues raised in the Intervenors' protest, and are the appropriate issues to include in the consolidated proceeding.
