**COMCAST PHONE OF FLORIDA, L.L.C.'S
MOTION TO ACCEPT POST-HEARING SUMMARY OF POSITION**

Comcast Phone of Florida, L.L.C. d/b/a Comcast Digital Phone ("Comcast"), pursuant to Rule 28-106.204, Florida Administrative Code, moves the Florida Public Service Commission ("Commission") to accept Comcast's late filed post-hearing summary of position, and in support of this request, Comcast states as follows:

1. The Prehearing Order in this matter, Order No. PSC-09-0494-PHO-TP, issued July 9, 2009, at page 8, requires each party to file as a part of its post-hearing brief a "summary of each position of no more than 50 words, set off with asterisks."

2. On August 20, 2009, Comcast filed its post-hearing brief. However, due to oversight, Comcast failed to include its 50-words or less summary of position. Comcast's Post-Hearing Brief should have included the following summary of position:

*** Comcast qualifies as a telecommunications carrier entitled to interconnection with TDS because of the authority it has received from the Commission to operate in the state of Florida as a telecommunications carrier and because Comcast actually offers and provides telecommunications services. ***

3. Comcast respectfully requests that the foregoing be incorporated by reference into its Post-Hearing Brief.


