



2 CHAIRMAN CARTER: And Item 16, there's an oral  
3 modification. Commissioner, you're recognized.

4 Staff, first let me come to you. Staff,  
5 you're recognized for an oral modification on Item  
6 16.

7 MR. DEASON: Yes. Good morning,  
8 Commissioners. I'm Jared Deason with the  
9 Commission staff.

10 Item 16 concerns an application for a  
11 staff-assisted rate case by Orange Lake Utilities.  
12 Orange Lake is a Class C water and wastewater  
13 utility located in Lake County.

14 Staff has an oral modification to correct an  
15 error in their CIAC amortization expense. This  
16 adjustment results in fallout changes to net  
17 operating income, revenue requirements, and rates.  
18 Specifically, Issues 7, 8, 11, and 12, as well as  
19 Schedule Numbers 3A, 3B, 3C, 4A, and 4B must be  
20 modified.

21 Commissioners and all parties have been  
22 provided with the effects of these changes, and  
23 staff is available for any questions the  
24 Commissioners may have.

25 CHAIRMAN CARTER: Commissioner Argenziano,

1                   you're recognized.

2                   COMMISSIONER ARGENZIANO: Mr. Chair, I just  
3                   want to be noted as voting against Item 16.

4                   CHAIRMAN CARTER: Okay. All right.  
5                   Commissioners, anything further on Item 16?

6                   Commissioner Edgar, you're recognized for a  
7                   motion.

8                   COMMISSIONER EDGAR: Motion incorporating the  
9                   oral modifications of our staff.

10                  COMMISSIONER SKOP: Second.

11                  CHAIRMAN CARTER: It has been moved and  
12                  properly seconded. All those in favor of voting  
13                  for Item 16, let it be known by the sign of "aye."

14                  (Simultaneous affirmative responses.)

15                  CHAIRMAN CARTER: All those opposed?

16                  COMMISSIONER ARGENZIANO: Aye.

17                  CHAIRMAN CARTER: Show it done. Thank you.
