### **RESOLUTION NO.** <u>09-63</u>

#### A RESOLUTION OF THE MAYOR AND TOWN COUNCIL CUTLER BAY. **FLORIDA** TOWN OF OF THE FLORIDA PUBLIC SERVICE SUPPORTING -THE COMMISSION'S DECISION ORDER FLORIDA TO POWER AND LIGHT TO DISCLOSE TOP EXECUTIVE SALARIES: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Public Commission (the "Commission") unanimously required Florida Power and Light ("FPL") to disclose top executive salaries during the PSC meeting of August 18, 2009; and

WHEREAS, FPL is currently petitioning the Commission to approve raising its electrical rates annually starting in 2010; and

WHEREAS, the Town, its residents, and the entire service area of FPL are each facing an economically difficult period; and

WHEREAS, these rate increases will adversely affect the residents of the Town and further strain limited resources; and

WHEREAS, those FPL customers subject to annual rate increases, if approved by the PSC, are rightfully concerned about executive salaries at FPL and have a stake the disclosure of those salaries, as those increases will be contributing to the salaries of the FPL executives; and

WHEREAS, the Town finds that this Resolution will promote the health, safety and welfare of the Town.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

<u>Section 2.</u> <u>Support.</u> The Town hereby supports the Florida Public Service Commission's decision to order FPL to disclose the top executive's salaries to the public prior to voting on the rate increase.

<u>Section 3.</u> <u>Authorization for Transmittal.</u> The Town Clerk is hereby directed to transmit this Resolution to the members of the Florida Public Service Commission, the Florida Legislature, the Governor, the Association of Counties and the Florida League of Cities for distribution to their respective memberships upon its adoption.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
