PROGRESS ENERGY FLORIDA'S MOTION TO TRANSFER DOCUMENTS

Progress Energy Florida ("PEF"), by and through its undersigned counsel, files this Motion to Transfer Documents to Docket 090009, and in support thereof state as follows:

1. On August 27, 2008, PEF filed Progress Energy Florida's Request for Confidential Classification Regarding Exhibits VF-1 and JAS-02 requesting confidential classification of portions of the final audit report, *Progress Energy Florida, Inc. Nuclear Cost Recovery Clause Levy County Units 1 & 2 Pre-Construction Cost*, filed with the PSC as Staff's Exhibit JAS-2 (PSC Document No. 07776-08). PEF also filed a Notice of Filing Affidavit in Support of the request (PSC Document No. 07780-08).
2. On July 27, 2009, Staff Counsel filed this same document as Exhibit JAS-1 to the direct testimony of Jeffrey A. Small in Docket 090009-EI (PSC Document No. 07621-09).
3. On September 10, 2009, Staff Counsel and PEF agreed that transfer of these documents to Docket 090009 would facilitate disposition and be a more efficient procedure.
4. PEF does not believe any party would be unduly prejudiced by granting this request.

For the reasons given, PEF requests the Commission to grant the Motion to Transfer


