



We are in receipt of your correspondence to Representative Sandra Adams where you expressed concerns with the wastewater increase outlined in staff's recommendation, dated June 17, 2010. To ensure that the Florida Public Service Commission (Commission) staff and the Commissioners have knowledge of your concerns, your correspondence has been placed on the correspondence side of the docket file for all to review. All consumer comments, including those that were received at the customer meeting, will be taken into consideration by the Commissioners in reaching their decision.

It is our understanding you believe that staff's recommended wastewater rates presented in staff's June 17th recommendation, consists of a calculation that is based on 2.1 people per household (pph). However, in this case, staff's recommended rates were not based on the number of pph. The number of pph is considered only when a repression adjustment is made to account for the reduction in consumption resulting from a price increase. Staff did not recommend a repression adjustment in this case due to the customer's low average consumption coupled with the fact that there was not a significant amount of discretionary or non-essential usage.

Staff's proposed wastewater rates were set based on two goals typically used by the Commission when designing wastewater rates. One of the goals is to design wastewater rates in which the base facility charge (BFC) cost recovery is set to 50 percent or more for the purpose of recognizing the capital intensive nature of wastewater plants. For this case, staff recommended setting the BFC cost recovery to 50 percent. The second goal is to set the residential monthly wastewater cap at a consumption level of 80 percent of the total residential gallons sold. This is based on the presumption that 80 percent of the gallons sold to customers will be returned to the wastewater system and the remaining 20 percent is used for outdoor purposes. Based on staff's analysis of the utility's billing data, this threshold is reached at appropriately 6,000 gallons (6 kgals) per month. Therefore, staff recommended that the Utility's current residential monthly wastewater cap of 6 kgals remain unchanged.

Since the filing of staff's recommendation on June 17, 2010, staff along with representatives from the Palm Valley Homeowners' Association (Palm Valley HOA) including yourself, the Palm Valley HOA consultant, the Office of Public Counsel (OPC), and CWS d/b/a Palm Valley Utilities (Utility) along with its consultant and legal counsel met on June 30, 2010 to discuss issues in this case. Based on that meeting, it was agreed that some additional adjustments would be made to staff's initial recommended revenue requirements for the water and wastewater systems. These adjustments will result in a decrease to staff's previously recommended revenue requirements for water and wastewater. As you are aware, there are still some outstanding issues that the Utility has to address.

On July 1, 2010, OPC sent out the discovery questions pertaining to those issues. The Utility filed its response to the discovery with our Commission Clerk's Office (Clerk) on July 23, 2010. On July 29, 2010, staff met with the parties, including you. At that time, it was determined that the Utility still needed to provide additional information. As a result, staff has rescheduled the filing of the recommendation to September 1, 2010 with the Agenda Conference being held on September 14, 2010.

Again, these meetings and discovery have lead to several adjustments which will decrease staff's recommended revenue increase as reflected in its recommendation of June 17, 2010. The Utility should be filing its response to the follow-up questions asked by OPC on or before August 13, 2010. This information will be filed with our Clerk's office. Therefore, you will also have access to the information through our website.






