The utility is requesting miscellaneous service charges based on the hourly rate of the maintenance technician and bookkeeper. The utility will only be charging miscellaneous service charges when a specific customer requests the service or is responsible for the service. The utility's justification for the miscellaneous service charges is to place the burden of these charges on the cost-causer rather than the general body of ratepayers.

The cost justification for each charge is as follows:

Bookkeeper hourly rate \$26

Maintenance technician hourly rate \$32

Initial Connection Fee

Bookkeeper .5 hour for telephone, correspondence and recordkeeping set-up	\$13.00
Maintenance technician .375 hour for connection	<u>12.00</u>
Total	\$25.00

Normal Reconnection Fee

Bookkeeper .75 hour for telephone, correspondence and recordkeeping for reconnect	\$19.50
Maintenance technician .33 hour for connection	<u>10.50</u>
Total	\$30.00

Violation Reconnection Fee

Bookkeeper .75 hour for additional billings, telephone, correspondence, and recordkeeping for reconnect	\$19.50
Maintenance technician .33 hour for connection	<u>10.50</u>
Total	\$30.00

Premises Visit Fee

Maintenance technician .5 hour for site visit and paperwork	<u>\$15.00</u>
Total	\$15.00

Late payment charge

Processing fee	\$5.00
