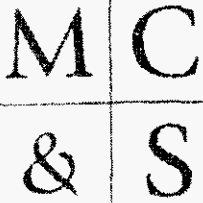



Sebring Gas System, Inc. ("Sebring"), by and through its undersigned counsel, submits its preliminary list of issues and positions for its consolidated natural gas division in connection with the hearing that is scheduled for November 2-3, 2009, in the above-styled docket.

ISSUES AND POSITIONS

Issue 1: What are the final conservation cost recovery true-up amounts for the period January 2008 through December 2008?

Sebring's Position: \$17,200 (overrecovery)

Issue 2: What are the total conservation cost recovery amounts to be collected during the period January 2010 through December 2010?

Sebring's Position: \$26,799 to be recovered.

Issue 3: What are the conservation cost recovery factors for the period January 2010 through December 2010?

Sebring's Position:

TS-1	\$0.09975/therm
TS-2	\$0.05041/therm
TS-3	\$0.03525/therm
TS-4	\$0.02871/therm

Issue 4: What should be the effective date of the new conservation cost recovery factors for billing purposes?

Sebring's Position: The conservation cost recovery factors should be effective for the period January 2010 through December 2010, and to billings thereafter until other conservation cost recovery factors are approved by the Commission.


