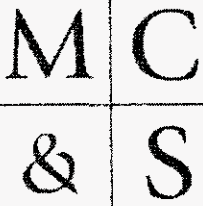



**FLORIDA PUBLIC UTILITIES COMPANY'S  
STATEMENT OF PRELIMINARY ISSUES AND POSITIONS**

Florida Public Utilities Company ("FPU") hereby submits its preliminary issues and positions to be taken up at the hearing scheduled for November 2-3, 2009 in this docket.

**Issue 1: What are the final purchased gas adjustment true-up amounts for the period January 2008 through December 2008?**

**FPU's Position: \$1,690,931 (underrecovery)**

**Issue 2: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2009 through December 2009?**

**FPU's Position: \$2,518,720 (overrecovery)**

**Issue 3: What are the total purchased gas adjustment amounts to be collected during the period January 2010 through December 2010 period?**

**FPU's Position: \$827,789 to be refunded.**

**Issue 4: What are the levelized purchased gas cost recovery (cap) factors for the period January 2010 through December 2010?**

**FPU's Position: 156.036 cents per therm.**

**Issue 5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?**

**FPU's Position: The factor should be effective for all meter readings on or after January 2010, beginning with the first or applicable billing cycle for the period January 2010 through December, 2010.**


