**REQUEST FOR CONFIDENTIAL CLASSIFICATION
OF REQUESTED AVIATION DATA**

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") requests confidential classification of certain aviation data provided at the request of the Florida Public Service Commission (the "Commission"). In support of its Request, FPL states as follows:

1. On September 16, 2009, and September 17, 2009, FPL provided requested aviation flight logs and passenger manifests, each time with a Notice of Intent to Request Confidential Classification. Pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, FPL was given 21 days to file a formal request for confidential classification. Pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, FPL is hereby requesting confidential classification of that information.

2. The following exhibits are included with and made a part of this request:

a. Composite Exhibit A consists of the confidential materials, on which all information that FPL asserts is entitled to confidential treatment has been highlighted. Composite Exhibit A is submitted separately and marked "CONFIDENTIAL."

b. Composite Exhibit B consists of an edited version of Exhibit A on which all information FPL asserts is entitled to confidential treatment has been redacted.

c. Exhibit C is a table containing a line-by-line and page-by-page identification of the information for which confidential classification is sought, and, with regard to each document or portions thereof, references to the specific statutory basis or bases for the claim of confidentiality and to the affidavit in support of the requested confidential classification. Please note that the first four items listed on Exhibit C, as well as the first four pages of Exhibits A and B, are pages which were inadvertently omitted from FPL's previous filings of this information.

d. Exhibit D contains the affidavit of Chris Bennett in support of this request.

3. FPL seeks confidential protection for the information highlighted in Exhibit A. The highlighted information is proprietary confidential business information within the meaning of Section 366.093(3), Florida Statutes. The information is intended to be, and has been, treated by FPL as private, and its confidentiality has been maintained.

4. Pursuant to Section 366.093, Florida Statutes, the information highlighted in Exhibit A is entitled to confidential treatment and is exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review, such as weighing the harm of disclosure against the public interest in access to the information.

5. The documents listed in Exhibit C contain information pertaining to FPL's affiliates which is related to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Specifically, the disclosure of this information could provide insight into the affiliated company's business plans or strategies. Such information is protected from public disclosure by Sections 366.093(3)(e), Florida Statutes.


These documents also include the personal phone numbers of employees. Such information is unrelated to the employee's compensation, duties, qualifications, or responsibilities, and is protected from public disclosure pursuant to Section 366.093(3)(f), Florida Statutes. None of the information identified as confidential is necessary to be able to determine the allocation of aviation expenses charged to FPL.

6. Upon a finding by the Commission that the information highlighted in Exhibit A, and referenced in Exhibit C, is proprietary confidential business information, the information should not be declassified for a period of at least eighteen (18) months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. *See* § 366.093(4), Florida Statutes.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials and affidavit included herewith, Florida Power & Light Company respectfully requests that its request for confidential classification be granted.

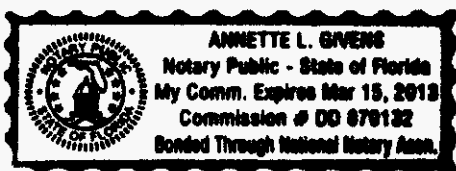
