RE: Closure of Docket Nos. 090086-TS and 090187-TS

On February 19, 2009, Docket No. 090086-TS, was established to investigate Roberta L. Marcus, Inc. d/b/a Marcus Centre's (Marcus Centre) apparent violation of Rule 25-24.565, Florida Administrative Code, Certificate of Public Convenience and Necessity Required. On April 14, 2009, Marcus Centre submitted an application to obtain a certificate to provide shared tenant services and Docket No. 090187-TS was established.

On May 12, 2009, in an effort to resolve the company's apparent violations in Docket No. 090086-TS, Marcus Centre submitted a proposed settlement offer. The company proposed to submit a payment in the amount of \$500 to be deposited into the General Revenue Fund. By Order No. PSC-09-0611-PAA-TS, issued September 8, 2009, the Commission accepted Marcus Centre's proposed settlement offer in Docket No. 090086-TS. The Commission also granted Marcus Centre a Certificate of Public Convenience and Necessity, STS Certificate No. 8761, to provide shared tenant services at 9990 S.W. 77th Avenue, Miami, Florida in Docket No. 090187-TS.

The Commission further ordered that the settlement payment should be received by the Commission within fourteen (14) calendar days after the issuance of the Consummating Order and that Docket Nos. 090086-TS and 090187-TS should be closed administratively upon receipt of the payment or upon disconnection of telephone service at 9990 S.W. 77th Avenue, Miami, Florida. The order became final and effective on October 2, 2009, upon issuance of Consummating Order No PSC-09-0658-CO-TS.

On August 19, 2009, Marcus Centre submitted the settlement payment in the amount of \$500. Marcus Centre has complied with the provisions of the Commission's Orders; therefore, Docket Nos. 090086-TS and 090187-TS shall be closed administratively.
