**PUBLIC SERVICE COMMISSION**

RULE NO: RULE TITLE

25-10.026: Location and Preservation of Records

25-10.111: Customer Billing

**PURPOSE AND EFFECT:** The purpose of both rule repeals is to eliminate redundant provisions which are no longer in use. These rules have been superseded by new sections in Chapter 25-30, e.g. 25-30.110 Records and Reports; Annual Reports; 25-30.115 Uniform System of Accounts for Water and Wastewater Utilities; 25-30.335 Customer Billing. Undocketed.

**SUBJECT AREA TO BE ADDRESSED:** These rules address utilities' responsibilities to maintain utility records within the State; to keep those records according to certain Accounting Standards; and to bill for service at regular intervals.

**SPECIFIC AUTHORITY:** 350.127(2), 367.121 FS

**LAW IMPLEMENTED:** 367.111, 367.121 FS
