Good Morning Mr. Morgan,

I just want to clarify that the service for customers leaving CIMCO is interexchange telecommunications services (long distance) and does not include local (dial tone). That seems clear to me in your filings, but just wanted to verify.

Also, Comcast Phone of Florida, LLC has a fictitious name on its registration/certification with the Florida PSC. The fictitious name is Comcast Digital Phone. Since this will be a docketed matter, the docket title will contain the complete name for Comcast. You do not need to file anything with the Clerk's Office. I will have them change the docket title to include the fictitious name. I just need you to acknowledge you agree with this. Your e-mail response will suffice.

I am assigning the docket to Ms. Melinda Watts. She will take it from here.
