

**AT&T FLORIDA'S NOTICE OF INTENT PURSUANT TO RULE 25-22.006**

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent.

1. On October 30, 2009, AT&T Florida filed its *Supplemental* Response to the Staff of the Florida Public Service Commission ("Staff's") First Request for Production of Documents Item No. 4 in the captioned docket.

2. Portions of the Response to Staff's First Request for Production of Documents Item No. 4 contains information that might be considered confidential business information to dPi Teleconnect, L.L.C. ("dPi"). AT&T Florida is now filing this Notice of Intent pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of this material without delay. In an abundance of caution, AT&T Florida is protecting the information under this Notice of Intent because it believes that the information might be confidential to dPi. If dPi believes that the information is confidential, dPi will need to file a Request for Specified Confidential Classification in 21 days from the date of the Notice of Intent, i.e. on or before November 20, 2009, to keep this information confidential as AT&T Florida will not be filing a Request for Specified Confidential Classification for same. The original of this notice has been filed with the Office of the Commission Clerk, and a copy has been served on all parties of record.


