NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Gainesville Renewable Energy Center, LLC (GREC LLC), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code (FAC), files this Notice of Intent to Request Confidential Classification for portions of the response to Interrogatory No. 55 from Staff's Second Set of Interrogatories (Nos. 9 – 70). The information for which GREC LLC intends to request confidential classification is proprietary confidential business information relating to GREC LLC's competitive interests, the release of which would harm GREC LLC's competitive business interests. 


